- FLEX PASSES DO NOT BESTOW ANY RIGHT OF OWNERSHIP OR LIABILITY FOR THE PROPERTY OR ASSETS OF EQUINELLE GOLF CLUB.
- EQUINELLE GOLF CLUB RESERVES THE RIGHT TO SET THE ANNUAL FEE AS WELL AS THE RIGHT NOT TO RENEW AN APPLICATION.
- EQUINELLE GOLF CLUB RESERVES THE RIGHT TO REPEAL PLAYING PRIVILEGES AND/ OR FLEX PASSES AT ANY TIME.
